



Australian Top Executive Climate Report 2009

ISSUE: Recent months have seen a major shake-up of executive pay in Australia

Hewitt CSi's *Top Executive Climate Report 2009* will be an important tool for organisations that need to review their executive pay strategies and structures in light of recent changes, by providing data on the impact of these changes on executive remuneration practice in Australia.

The report will contain detailed benchmarking information related to salary packaging, benefits and long and short term incentive plan design for executives. It will also include statistics on executive staff attrition and forecast salary increase budgets.
